

Georgia Council for Recovery (GC4R) Privacy Policy

Effective Date: March 25, 2026

The Georgia Council for Recovery (GC4R) is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and safeguard your information when you engage with our peer recovery support services, including SMS/text messaging.

Information We Collect

We collect only the minimum information necessary to provide recovery support services, including:

- First name
- Phone number
- ZIP code (to connect you with local resources)

We do **not** collect sensitive personal health information via SMS.

How We Use Your Information

We use the information you provide to:

- Offer **peer-based recovery support, encouragement, and check-ins**
- Coordinate services and connect you with recovery resources
- Provide information about available support services in your area

All SMS communications are **non-promotional** and are solely intended to support recovery and service coordination.

How We Share Your Information

GC4R does **not sell, rent, or share your personal information** with third parties for marketing or promotional purposes.

We may share limited information only when necessary to:

- Coordinate recovery services with trusted partners (when appropriate and permitted)
- Comply with legal or regulatory requirements

SMS consent is not shared with third parties or affiliates.

SMS Communication & Consent

By providing your phone number, you agree to receive SMS messages from GC4R related to:

- Peer recovery support
- Service coordination
- Resource connection

Message frequency may vary. Message and data rates may apply.

You may opt out at any time by replying **STOP**. For assistance, reply **HELP**.

Data Security

We take reasonable administrative and technical measures to protect your information. We limit access to authorized personnel only and follow applicable privacy standards, including HIPAA and 42 CFR Part 2 where applicable.

Your Privacy Rights

You have the right to:

- Request access to your information
- Request correction or deletion of your information
- Opt out of SMS communications at any time
